New Budget for 2013: priority lift station, gutters, parking, resurfacing roads, Lynn to get bids on all 4 items. Gail to send info she got from the neighborhood meeting to Lynn. Ask about bids for speed bumps. Can also take out handicapped parking and make it into two spaces.

Joann – brings up starting a neighborhood watch. Suggest using a website as regular communication with others. Owners only have access to that. Gail said she knows of a neighborhood class for websites. Send a letter out to every owner asking them to be on a list serve. Bobby can help get the website started.

Question from Owner about trees. Trees on the other side of fence growing into roof. HOA will address this with the tree company, but we can cut down anything that is on our side of the property.

Joann – the bulletin board, why facing that way? Leslie – can we remove two feet of bushes in front of bulletin board so people can walk up and read it clearly. Lynn – refund check? Wanda has been sick regarding refund check.
